Now, the past is behind her, thirty years of anxiety, hardship and agony. Today, she enjoys the fruits of her labour- two of her children are engineers, one is a doctor and another is a teacher. Even as she reminisces about her past, there is not a tinge of bitterness because she knows that the toil and hardship were all worthwhile.
